IN CONNECTION WAVE KUDESK PROGRAM AIMED AT SPOTTING REFUGEES IN WAVE AREA WHO CAN SERVE AS INTERMEDIARIES TO REACH AND ULTIMATELY RECRUIT PERSONS IN PBRUMEN FOR KUDESK PURPOSES, WAVE IN CONTACT SUBJ REF FOR DEBRIEFING RE HIS ALLEGED INTIMATE RELATIONSHIP WITH EFIGENIO (AMEJEIRAS) DELGADO, EX-CHIEF PNR (NATL REV POLICE), NOW VICE MIN ARMED FORCES FOR SPECIAL AFFAIRS, AND SUBJ'S ALLEGED ACQUAINTANCE WITH RAUL (DIAZ) ARGUELLES, EX-DTI CHIEF, AND SAMUEL (RODILES) PLANAS, EX-PNR MBR.

2. AMOT-20 WHO KNEW SUBJ REF CUBA REPORTED FOLL:

A. SUBJ FORMER MEMBER UNION INSURRECCIONAL REVOLUCIONARIA, AN ALLEGED GANSTER ORG HAVA IN 50'S OF WHICH FIDEL CASTRO ALSO MEMBER.

B. MEMBER GROUP THAT ASSASSINATED 2ND CHIEF CUBAN SECRET POLICE "CUCU" (HERNANDEZ) VEGA IN CUBAN EMB MEXI 48.. SUBJ ESCAPED MEXI WITH ASSISTANCE DIEGO (RIVERA), MEXI MURALIST AND COMMIE.

C. ASYLEE HAITIAN EMB HAVA 56 AFTER CUBAN POLICE UNCOVERED PLOT ASSASSINATE BATISTA.

D. SUBJ AND OTHERS ARRESTED SAN JOSE, COSTA RICA, 57 FOR

ATTEMPTED KIDNAPPING COSTA RICA PRES JOSE (FIGUERES). RELEASED COSTA RICAN PRISON JAN 59 THROUGH ARRANGEMENTS MADE BY AMEIJERAS, THEN PNR CHIEF AND PERSONAL FRIEND ) SUBJ.

E. AMOT-20 EVAL SUBJ: FOND OF GAMBLING AND CAPABLE COMMITTING ANY CRIME FOR MONEY.

3. FOLL OBTAINED AMOT-133 FROM RAUL (ROS) GONZALEZ (DPOB 24 APR 22, GUANTANAMO, ALLEGED CASTRO AGENT MIAMI. SEE 210-279603 AND SAS/CE CARDS AVAILABLE HQS), WHO SPOKE TO SUBJ REF 24 JUL 63:

A. SUBJ SAID HE ARRESTED 17 APR 61 AT TIME BAY PIGS INVASION AND DETAINED LA CABANA 70 DAYS. AMEIJERAS ARRANGED RELEASE FROM PRISON.

B. ARRESTED AGAIN ABOUT MAR 62 ON SUSPICION CONSPIRING AGAINST REGIME. DETAINED 20 DAYS IN G-2 OFFICES, MIRAMAR. SUBJ SAID HE DID NOT OCCUPY ANY OTHER OFFICIAL POSITION AFTER RELEASE.

C. SUBJ BROUGHT MSGS MIAMI FOR DR. CARLOS (PRIO) SOCARRAS FROM "PEPE" DE JESUS (HINJAUME) (MAT UNO REGARDING PLAN ASSASSINATE FIDEL CASTRO. (NO WAVE TRACES HINJAUME.)

4. AMOT-133 OBTAINED FOLL RE AMEIJERAS IN INTERVIEW 30 JUL WITH SUBJ REF:

A. AMEIJERAS CURRENTLY LEADER PRO-US ANTI-COMMIE GROUP REV ARMY COMPOSED NUMEROUS UNIDENTIFIED JUNIOR OFFICERS AND FOLL MAJORS WHO WAITING OPPORTUNITY ACT IN FAVOR ANY MOVEMENT WHICH DOES NOT INVOLVE BATISTIANO ELEMENTS: JUAN (ALMEIDA) BOSQUE, SAMUEL (RODILES) PLANAS, RENE (RODRIGUEZ) DE LOS SANTOS, ROLANDO (CUELLAS) SECADES, RAUL (DIAZ-ARGUELLES) GARCIA, OSCAR (FERNANDEZ) MEL, JOSE (PONCE) DIEZ (LATTER BROTHER-IN-LAW RAMIRO (VALDES) MENENDEZ, MIN INTERIOR).

B. COMMIE GROUP CONSISTS OF RAUL (CASTRO) RUZ, ERNESTO "CHE" (GUEVARA) DE LA SERNA, RAMIRO (VALDES) MENENDEZ, FLAVIO (BRAVO) PARDO (FORMER PRES COMMIE YOUTH, NOW REV ARMY CHIEF OPNS), AUGUSTO (MARTINEZ) SANCHEZ, FELIX (TORRES) GARCIA, WILLIAM (GALVEZ) RODRIGUEZ.

C. CMDTE GUILLERMO (GARCIA) FRIAS, CHIEF MANAGUA CAMP, NOT MBR EITHER ABOVE GROUP AND LOYAL FIDEL.

D. FIDEL (CASTRO) ALLEGEDLY AWARE EXISTENCE ANTI-COMMIE GROUP HEADED BY A AND ACTS AS MODERATOR BETWEEN THEM IN ORDER MAINTAIN COHESION GOC.

E. A. ALLEGEDLY RELIEVED DUTIES AS CHIEF STAFF CENTRAL ARMY DUE POLITICAL/IDEOLOGICAL DIFFERENCES WITH CMDTE FELIX (TORRES) GARCIA. SUBJ REF SAID ALTHOUGH COMMIES WON ANOTHER FIGHT AGAINST A, HE WILL NOT ALLOW HIS ARM BE TWISTED AND CONTINUES SHOW CONTEMPT FOR COMMIES WHENEVER OPPORTUNITY PRESENTS ITSELF.

5. VIEW BACKGROUND SUBJ REF, IT OBVIOUS FIRST STEP WAVE WILL TAKE AFTER DEBRIEFING WILL BE ESTABLISHMENT HIS BONA FIDES AND VERACITY HIS CLAIMS. ALSO BASED ON RESULTS DEBRIEFING WAVE WILL DETERMINE SUBJ'S POSSIBLE UTILITY EITHER AS KUDESK AGENT CANDIDATE OR AS POTENTIAL MHAPRON ASSET.
