Oswald leaves his wedding ring at Mrs. Paine's residence, where Marina finds it after the police come in the afternoon. (23:477) Marina says that this is the first time that he has ever left it. (1:72,73; 2:18,315; 22:764; 23:399; contra 24:230) (7:180 - Does Oswald give his USMC emblem ring to Detective Sims?)

Oswald leaves Mrs. Paine's residence at 7:00 a.m., which is earlier than usual. (Time Feb. 14, 1964:19) (Recall that Oswald is seen at Hutch's Grocery, .8 mile from Mrs. Paine's, on several mornings at 7:00 a.m. [10:329; 26:178])

Marina says that Oswald has a small package with his lunch sack when he leaves Mrs. Michael Paine's residence. (1:73) At Clay Shaw's trial, Marina says that she does not see Oswald leave. (New Orleans Times Picayune 2/22/69)

On 11/30, Marina says that she does not know of anything that Oswald takes with him. She does not recognize the bag found on the 6th floor of the TSBD. (22:751)

On 11/23, Oswald denies that he takes a package to work on 11/22. (24:18)

7:10 a.m. - Mrs. Randle sees LHO with 2' or over package wrapped in brown paper, some weight to it. She watches him put it in Frazier's car. LHO comes to window, waves, Frazier leaves. (SS interview 11/28) (CD87:SS175:2)

7:10 am to 7:15 a.m. - Mrs. Randle, Wesley Frazier's sister with whom Frazier lives, sees Oswald approach the Randle residence in a light brown or tan shirt. (24:223) Oswald is carrying a long package. On 12/1, Mrs. Randle says it is about 27" long. (24:408) On 11/22 Mrs. Randle says it approximately 3' x 6" (CD5:320) No jacket?!!

7:20 a.m. - Wesley Frazier sees Oswald look in the Randle's kitchen window. (24:408)

7:20 a.m. - Marina sees no signs of Oswald having breakfast in Mrs. Paine's kitchen. (22:747; 23:412)

Oswald puts package on the back seat of Frazier's car and Frazier indicates that the package is about 2' long. (24:209; 26:385) On 12/1 Frazier indicates that the package is about 27" long. (24:409) Oswald calls this package 'curtain rods.' (26:385; CD5:316-317) Frazier says 'sack' is like one coming from 5¢ & 10¢ store. (FBI Report, CD1:5) (CD5:317)

Frazier and Mrs. Randle testify that the package is about 28" long. (26:385; Washington Post 12/1/63:E-4)

Michael Paine estimates length of blanket bundle in garage as 37" (2:415) 37-1/2" (9:438) Thinks rifle in one piece. (9:446)

Pictures of the bag and rifle with a tape measure are in (22:480) FBI Lab. Frazier testifies rifle is 40.2" overall and breaks down into 34.8" and 28.9" components. (3:395)

7:25 a.m. - Frazier and Oswald leave the Randle residence in Frazier's 1954 black 4-door Chevrolet sedan, 1963 Tex. License VK 3926. (24:223, 293,408)

Oswald does not bring his lunch and tells Frazier that he is going to buy it. (24:209)

On 11/23, Oswald said his lunch was only package he brought to work on 11/22. (24:482)

November 22, 1963 (Friday) - Oswald spends the night of November 21/22 at Mrs. Michael Paine's residence in Irving. (24:209,695)

On 11/22, Marina says that Oswald leaves before she or Mrs. Paine are awake. (23:383)

On 11/22, Mrs. Michael Paine says that she is asleep when Oswald leaves. (24:221)

On 11/22, Marina says that Oswald is gone when she gets up. (24:219)

On 11/28, Marina says alarm goes off at 6:40; LHO gets up at 7:00. Marina does not get up; talked to LHO, "Good-bye," etc. (CD 344:26).

On 11/30, Marina says that the alarm at 6:40 a.m. awakens her but not Oswald. She nurses the baby and awakens Oswald at 7:00 a.m. (22:747; 23:412) On 9/11/64, Marina says she does not get up when LHO does, nor does she fix his breakfasts. (CD 1546:237)

Mrs. Michael Paine says that Marina is nursing the baby when Oswald gets up at 6:30 a.m. (Redbook, July 1964:88)

At Clay Shaw's trial, Marina testifies that, "I was awake but I did not get up, because he told me to stay in bed." (New Orleans States Item, 2/21/69)

November 22, 1963 - 7:00 a.m.

Marina to FBI 9/5/64 (CD 1546:221-225, 229-231)

- a. LHO prepares no document similar to one at time of General Walker's shooting.
- b. LHO's unusual actions (but only in retrospect):

November 22, 1963 (Friday) - Oswald spends the night of Nov. 21/22 at Mrs. Michael Paine's residence in Irving. (24:209,695)

On 11/22 Marina says that Oswald leaves before she or Mrs. Paine awake. (23:383)

On 11/22 Mrs. Michael Paine says that she is asleep when Oswald leaves. (24:221)

On 11/22 Marina says that Oswald is gone when she gets up. (24:219)

On 11/28 Marina says alarm goes off at 6:40; LHO gets up at 7. Marina does not get up; talked to LHO, "Goodbye" etc. (CD 344: 26)

On 11/30 Marina says that the alarm at 6:40 a.m. awakens her but not Oswald. She nurses the baby and awakens Oswald at 7:00 a.m. (22:747; 23:412) On 9/11/64 Marina says she does not get up when LHO does nor does she fix his breakfast. (CD 1546:237)

Mrs. Michael Paine says that Marina is nursing the baby when Oswald gets up at 6:30 a.m. (Redbook, July 1964:88)

At Shaw's trial, Marina testifies that "I was awake but I did not get up, because he told me to stay in bed." (NOSI 2/21/69)

(24:223, 293, 408)

Oswald does not bring his lunch and tells Frazier that he is going to buy it. (24:209)

On 11/23 Oswald said his lunch was only package he brought to work on 11/22. (24:482)

On 11/22 Oswald tells Captain Fritz that he ate a cheese sandwich and an apple which he brought as a lunch from Mrs. Paine's house. (24:19)

Oswald tells Frazier that he will not be riding to Irving with Frazier this afternoon. (26:385; WP 12/1/63:E-4; 24:409)

Arrive at Depository at 7:55. (CD5:317)

After leaving the car in the parking lot, Oswald carries the package in his right hand with the other end in his armpit. (24:409; CD897:23,24)

On 11/22/63 Marina says that Oswald did not return to Irving this day. (23:384)

November 22, 1963 - Friday 8:00 a.m.

On 11/23 TSBD Superintendent Truly says that the depository itself has 19 employees with Oswald being a temporary employee. (24:227)

The payroll record, which is also the attendance record at the TSBD, is inaccurate:

(1) Oswald is listed as 'Leslie' Oswald. (23:751)

(2) Oswald is credited for 8 hours work every day, including 11/22 (23:751)

(3) Frankie Kaiser, a TSBD employee who lives in a trailer court at 5230 W. Ledbetter, Redbird Trailer Park (a good one) (Tippit's District?), is absent from the TSBD on Thursday and Friday with a tooth ache. (At the time of the assassination he is at the Baylor Dental School). (6:342)

The TSBD records show that Kaiser is working 8 hours both of these days! (23:751) (25:602)

TSBD superintendent says that Kaiser was not working either day. Kaiser is an order clerk and truck driver. He finds Oswald's jacket on the first floor and his clipboard on the sixth floor several days after the assassination. (Kaiser finds the clipboard on 12/2.) (26:824,825 has pictures of the clipboard.) (3:234; 6:334,343,345; 16:958; 20:334,335; 23:816; 24:1)

FBI Lab examined jacket per DPD request of 12/21/63. Q-350 - Nothing re laundry marks. (CD 321:52,53) No textile fibers from rifle can be associated with this jacket. Hair from LHO's head similar to hair found, but limb (arm) hair fragments don't have enough characteristics (CD329:52)

At 8:00 a.m. Jack Dougherty, a TSBD employee who is on the 5th and/or 6th floor at 12:30 p.m., sees Oswald enter the building without a package. (6:376; CD206:11) Dougherty starts at 7:00 a.m. (CD5:366)

At 8:00 a.m. Oswald enters the TSBD and places his blue jacket on the sill of the easternmost window on the north wall of the first floor domino room. Frankie Kaiser finds it here several days later. (6:345; 16:958; 20:334)

On 12/19 Marina recognizes this jacket as Oswald's blue one. (23:475)

At 8:00 a.m. superintendent Truly sees Oswald in the building. (22:677)

About 8:00 Danny Arce sees Oswald on first floor TSBD. (CD205:7)

Between 8:05 a.m. and 9:00 a.m. James (Junior) Jarman, a checker on the first floor, sees Oswald on the first floor. Jarman is a colored employee. (3:200; 24:213)

On 11/24 Jarman says he sees LHO on the 1st floor at 8:15 a.m. (CD 5:334)

At 8:30 a.m. Wesley Frazier sees Oswald working in the TSBD. (24:209)

November 22, 1963 - Friday 9:00 a.m.

Between 9:30 a.m. and 10:00 a.m. Oswald asks James (Junior) Jarman about the Presidential motorcade route. (3:200; 24:213; CD 5:334)



(6) Charles D. Givens, Negro - lists no names (24:210)

This man has been convicted under a narcotics charge. 37, 6' 3", 165 #, Dallas Sheriff Department # 37954 (17:419)

(7) James ( Junior ) Jarman, Negro:

November 22, 1963 - Friday 10:00 A.M.

At 10:00 a.m. Eddie Piper comes to work at his usual starting time at the TSBD. (26:544)  
Piper sees Oswald on the first floor. Oswald describes Piper as a 'little short negro'.  
(6:383) *only time Piper sees LHO 11/22. (CD 206:13)*

At 10:00 a.m. Oswald is filling orders for books to be shipped. ( Life 2/21/64)

TSBD employee Billy Lovelady, white, says that Oswald asks him the location of certain books on the 6th floor. (22:662) *Lovelady sees LHO on 6th floor. (CD 5:332)*

At 10:15 a.m. Harold ( Hank ) Norman, a Negro, sees Oswald looking out of the Elm Street windows on the first floor. (3:188) *10:20/10:30 Norman sees LHO. (CD 329:14)*  
These windows have a decorative screen of pierced concrete panels and the view is restricted.

During the morning, Bonnie Ray Williams says that many employees are planning on watching the Presidential Motorcade from the 6th floor. (3:169)

*10:30 - R. E. Lewis sees LHO on 1st floor. (CD 205:23) (TAG 1:462 - says sees LHO @ 10am) (TAG 5:64)*

November 22, 1963 - Friday 11:00 A.M.

At 11:00 a.m. Wesley Frazier sees Oswald on the first floor. (24:209) *For last time. (CD 5:318)*

*11:00 a.m. Danny Arce sees 0" piece of paper on 6th floor. (CD 205:7) (CD 206:11)*

At 11:00 a.m. Jack E. Dougherty sees Oswald on the 6th floor getting books. (6:377) (CD 5:366)

*Dougherty says he does not see LHO afterwards. (CD 206: -; "FBI Archives: 34)*

At 11:30 a.m. Oswald eats lunch with Negro TSBD employees Eddie Piper and James ( Junior ) Jarman on the first floor. (24:267, 482) *Cheese, bread, fruit & apples.*

*Could it be Harold Norman instead of Eddie Piper? (Meagher: 225)*

On 11/22 Oswald tells Captain Fritz that he eats lunch with 'Junior' and some other employee on the second floor at the time of the assassination (12:30 p.m.). (4:224, 231) (24:264)

Oswald tells Captain Fritz that he eats his lunch in the lunchroom on the second floor and possibly 'Junior' and a short Negro TSBD employee walk through the lunchroom while Oswald is there. Oswald has a cheese sandwich and an apple & lunch which he brought

from Mrs. Michael Paine's Irving residence. (24:19)

Oswald tells Captain Fritz, according to FBI agent Hosty, that he eats lunch on the first floor and is still there at 12:30 p.m. (17:786)

Recall that the TSBD lunch period is from 12:00 noon until 12:45 p.m. (3:214; 22:162; 24:872; 25:601; DFP 12/7/63:A-2)

At 11:45 a.m. James ( Junior ) Jarman, a Negro, says that all the workers on the 6th floor, including himself, leave and are out on the street by noon. (24:213)

Between 11:30 a.m. and 12:00 noon James ( Junior ) Jarman, a Negro, sees Oswald get on an elevator on the first floor to go and get some boxes. (24:213) *order filler pad. (CD 5:334)*

At 11:45 a.m. Bill Shelley, a white supervisor, does not see Oswald on the 6th floor. (24:206) *Shelley last sees LHO between 11:45 & 12 noon. (CD 5:371) (11/22)*

Between 11:30 a.m. and 11:50 a.m. Billy Lovelady (white) says that he, Bill Shelley (white), Jack Dougherty (white), Danny Arce (Mexican), Charles Givens ( Negro ) leave the 6th floor to see the President. (6:337; 24:214)

Between 11:40 a.m. and 11:45 a.m. Bonnie Ray Williams (Negro) sees Oswald on the east side of the 6th floor. (22:681) *(1/8/64 - Williams says he sees O on 5th floor & O asks elevator he sent back. (CD 329:13))*

At 11:50 a.m. Bill Shelley, a white supervisor, sees Oswald on the first floor near a telephone. (7:390; 22:673)

At 11:50 a.m. Billy Lovelady (white) says that he and Bonnie Ray Williams go down on the west automatic elevator from the 6th floor and Oswald is standing by the east non-automatic elevator on the 6th floor. (6:337) *(11/22/63 - Lovelady @ 11:50 "Williams, Arce & another Negro male start down from 6th floor on 2 elevators. O calls for them to stop on 5th but they don't. (CD 5:332))*

At 11: a.m. Bonnie Ray Williams (Negro) says that he and Charles D. Givens, a Negro TSBD employee who is a narcotics ex-convict, go down from the 6th floor on the east non-automatic elevator. (3:168) *@ 11:50 (CD 5:330) 11/23/63. Williams sees LHO on 5th floor.*

At 11:30 a.m. Charles Givens says he went downstairs to the bathroom. (11/22 -24:210) *(CD 1064:10)*

At 11:45 a.m. Charles D. Givens, a Negro TSBD employee who is a narcotics ex-convict, says that he, Bonnie Ray Williams (Negro), Danny Arce ( Mexican ) and Billy Lovelady (white) are on an elevator going down from the 6th floor when they pass Oswald on the 5th floor. (6:349)

Between 11:40 a.m. and 11:50 a.m. Danny Arce (Mexican) sees Oswald on the 5th floor. (24:199) *near elevator. (CD 205:8)*

At 11:55 a.m. Danny Arce ( Mexican ) says that he, Bonnie Ray Williams (Negro) and Billy Lovelady (white) ' race down ' on the east non-automatic elevator. Arce thinks that Oswald is on the 5th floor. (6:364)

Shortly before noon Jack E. Dougherty (white) sees Oswald on the 6th floor. (24:206)

At 11:55 a.m. Charles D. Givens (Negro ex-convict) takes the east non-automatic elevator to the 6th floor to get his cigarettes. *(CD 1064:9) 10 says @ 11:45 a.m. & LHO is standing in SE corner of building.* Givens sees Oswald on the 6th floor, walking northward (toward the wall that the elevators adjoin), 30' - 40' north of the building's south wall ( along Elm Street ) and 10' west of the building's east wall ( along Houston Street ) with a clipboard in his hand.

CD296:3 (Insp. Holmes' report of 11/24/63 Oswald interview) - At lunchtime colored fellow invited Oswald to go with him. Oswald said, "You go on down and just send the elevator back up and I'll join you in a few minutes."

CD5:329 - Givens on 11/22 says the exchange re: elevators is at 11:30)

Givens asks Oswald if he is going to lunch. Oswald says, "No. Close the gate on the west (automatic) elevator," or "Not now. Just send the elevator back up." When Givens returns to the first floor on the east non-automatic elevator, the west automatic elevator is not there. (6:349,351; 24:491; WP 12/1/63:E-4; FBI Report, CD1:6)

Bill Shelley says Rolling Reader boxes used to conceal Oswald's position were 1/2 building width away from their correct position. (7:391)

At 11:50 a.m. Bonnie Ray Williams (negro) says that he gets a Dr. Pepper and takes the east non-automatic elevator to the 6th floor where he sits down by the 3rd set of two windows on the south building wall (Elm) counting from the east building wall (Houston). Williams ate some chicken and drinks the Dr. Pepper. 1/8/64 Williams says he eats on the 6th; goes to 5th at 12:05. (CD 329:13) As no one else comes up and it is so quiet, Williams puts the empty bottle down by a cart and goes down to the fifth floor where he finds Harold (Hank) Norman (Negro) and James (Junior) Jarman. (3:171,172,173) Check CE 2003 (Meagher:40) Williams goes to 6th floor; stays 3 minutes; goes down stairs to 5th; hear 2 shots overhead. (CD5:330)

Check on the location of chicken bone fragments and 'lunch sack(s)' on the boxes surrounding Oswald's hiding place as it might indicate how close Williams comes to Oswald. (Meagher:39,40)

November 22, 1963 - Friday 12:00 Noon

At 12:00 noon, Eddie Piper sees Oswald on the first floor. (6:383) DPD Statement 2/18/64=Piper tells LHO he is going to eat sandwich and Oswald mumbles something that he is going up to eat. (TAG 1:467)

At 12:00 noon Charles D. Givens, a Negro ex-convict, goes to visit a friend at a parking lot at Elm and Record. (24:210; CD 1069(c):11) This is the 100 block of North Record. ("Friend" Edward Shields says 601 Main. James Lacy = friend. (See N.385)

On 11/21 Jack Ruby had visited the AAA Bonding Service, 106 N. Record, around noon. Re: Phil Hodges, bonds, 607 Main; Best Cafe, 601 Commerce (1962 City Directory) (25:190,215,321,322)

A list of Dallas gamblers on April 2, 196 , includes:

"17. Smith and Stovall, 106 S. Record, bail bondsman"(23:166)

On 1/8/64 Jarman says he, Norman and Williams eat lunch on 1st floor around noon; 12:25 take west elevator to 5th floor. Hear shots and go downtown. (CD 329:12) On 1/8/64 Norman says Jarman and he eat lunch on 1st floor; go outside. Go to 5th on west elevator and Williams joins them. (CD 329:14)

Between 12:10 p.m. and 12:25 p.m. James (Junior) Jarman and Harold (Hank) Norman take the west automatic elevator to the 5th floor.(3:210; 24:229)

They see the east non-automatic elevator at the 6th floor. (3:190)  
(12:10/12:25 would indicate Williams came down at 12:15 p.m.??)

Bonnie Ray Williams (Negro) says that James (Junior) Jarman and Harold (Hank) Norman have already reached the 5th floor on the west automatic elevator when he comes down from the 6th floor on the east non-automatic elevator. (3:172) At 12:05 (CD329:13)

12:10 p.m. (CST) = 10:10 a.m. (PST) (CD 1107:82,83)

Two experienced (6 years) telephone operators on a toll call line servicing 12,000 phones in Oxnard, California, report:

- (1) Voice of middle-aged woman.
- (2) At 10:07/10:08 a.m.: "The President is going to die at 10:10" (12:10 CST)
- (3) This said so rapidly that it might have been read: "The Justice, the Supreme Court, there is going to be a fire in all the windows; the Government is going up in flames."
- (4) Named 12 courts in order of importance starting with the Supreme Court to Probate Court and Juvenile Court.
- (5) "The President is going to die at 10:30." (12:30 CST)
- (6) Courts again mentioned.
- (7) "The Government takes over everything; lock, stock and barrel."
- (8) One of the operators heard: "thermostat, rheostat, heostat."
- (9) Lasted 10-15 minutes. Operators switched to other calls. This caller was never connected to anyone else. At one time when operator offered help, the voice said, "Please get off the line; I'm using the phone." (This was a party line.)

(Legacy of Doubt:234 says Bobby Kennedy very curious about call and investigated Oxnard 5/28/68) Call from Oxnard-Camarillo area 50 miles north of Los Angeles.

At 12:10 p.m. TSBD president Cason leaves the building to go home. (22:640)

12:15 p.m. (-) - Mrs. R. E. (Carolyn) Arnold tells FBI on 11/26/63 that Oswald was in hallway between front door and double doors a few minutes before 12:15. (CD5:41 - Archives - Meagher:225)

On 11/22 Jack E. Dougherty says that he works on the 6th floor until noon and then goes to the first floor to eat his lunch. At 12:45 p.m. Dougherty goes back to work and is on the 5th floor getting some stock when he hears a shot. (CD5:366; CD206:11)

12:15? - LHO is seen on 5th floor (CD 1210:4 - Sgt. Gerald Hill)

At 12: p.m. Jack E. Dougherty (white) goes back to work on the 6th floor (This indicates ! that Dougherty calls the west automatic elevator down from the 5th floor and returns on it to the 6th floor.)

12:15/12:20 ? - Danny Arce assists old man with kidney trouble to men's room on west side of 2nd floor of TSBD. (6:366,367) Sees him leave in black car. Arce describes (on 11/22/63) as real old man in old brown suit and western type hat. Arce sees him leave TSBD and drive off in old black Buick. Old man is in TSBD after lunch but not carrying anything in hands. (TAG 1:5)

TSBD superintendent Truly says that the normal lunch period is from 12:00 noon until 12:45 p.m.; however, as Dougherty comes an hour earlier than the other employees in the morning, perhaps his lunch period is different.

Jack E. Dougherty (white) takes the west automatic elevator on the 6th floor and goes to the 5th floor where he is about 10' from the elevator when he hears something that he thinks.

(b) is a shot overhead (CD206:11; 3:228,229; 6:379,380; 22:645; 24:206)

White male, 28, sallow complexion, foreign appearance, very prominent nose, goes to Anderson Studios, Cedar Springs and Harwood, and asks to make Long Distance collect call to Indiana. Leaves without completing the call. Nervous. Just as reports of shooting come in. (CD5:439( Rel? W. D. Sanders

Geneva Hine, only employee in TSBD second floor office, says power went off and phones went "dead" in TSBD as pilot car of motorcade approached TSBD. (6:395; CD5:3\_ \_)
