Other Individuals and Organizations Involved of Interviewed

FRANK KRYSTINIK, 2121 Greenway Drive, Arlington, Texas, an engineer at Bell Helicoptor Company, advised that he has been a fellow employee with MICHAEL PAINE at the Bell Helicoptor Company Research Laboratory in Arlington, Texas, for several years and based upon his knowledge of MICHAEL PAINE he can state he is definitely not pro-Marxist in any way, and is in favor of the democratic and capitalistic system that exists in the United States. Mr. KRYSTINIK advised that he has also visited with MICHAEL and RUTH PAINE on a social basis, in addition to his dealings with MICHAEL PAINE at work.

Mr. KRYSTINIK advised that on one occasion, in late Cotober or early November, 1963, he met LEE HARVEY OSWALD at a meeting held at Southern Methodist University in Dallas, Texas.

Mr. KRYSTINIK advised that he and LEE HARVEY OSWALD started arguing over OSWALD's beliefs. At this time, MICHAEL PAINE just walked away with a disgusted look. MICHAEL PAINE later advised KRYSTINIK that he had attempted to argue with OSWALD in the past and decided it was of no use, that he had a closed mind.

KRYSTINIK described the PAINES as extremely charitable people who were very kind by nature.

KRYSTINIK further advised that MICHAEL PAINE had confided in him that his father, LYMAN PAINE, who resides in California, had associated with people of questionable views. MICHAEL PAINE had further stated to KRYSTINIK that he was not in agreement with his father or his friends, or their views.

KRYSTINIK further stated that based upon his association with MICHAEL PAINE, he did not appear to have any close feeling toward his father, but appeared to be closer to his step-father, Mr. ARTHUR YOUNG. KRYSTINIK stated he once asked MICHAEL PAINE what kind of man his father was, and MICHAEL PAINE just shook his head and said "you tell me, frankly I can't figure him out."

KRYSTINIK further stated that he feels certain that MICHAEL PAINE is opposed to Marxism and is in favor of the capitalistic system because he knows MICHAEL PAINE is planning on starting his own business in the near future. KRYSTINIK stated he knows that MICHAEL PAINE spent \$3,000.00 in the early part

of August, 1963, to purchase a tract of industrial property in Irving, Texas, where he intends to build his small plant.
KRYSTINIK stated it is MICHAEL PAINE's plan to have a profit sharing plan' or similar type plan' for his employees but is definitely in favor of the capitalistic system in this operation.

KRTSTINIK advised he is aware that MICHAEL PAINE ... visited his father in August, 1963, but feels that MICHAEL PAINE has visited his father more out of a sense of duty than out of any feeling of loyalty to his father.....

KRYSTINIK said he feels he can unqualifiedly loyal characterize MICHAEL PAINE as an individual completely/to our country and form of government, and dedicated to its ideals.
